Site Name: Site name or name of general area e.g. Fort Saint-Louis (site) or The Hawk beach (area)

Site Borden Number: alpha-numeric number e.g. BdCv-88

Date(s) Visited: when was the information collected?

<u>Site Photo</u>: photo(s) showing current condition of the main portion of the site and any changes to the site, in jpg file format

<u>Site Cannot be Accessed</u>: check if you are not able to physically visit the site area.

Site Cannot be Located: check if you are not able to find the site itself

General site description: what you see at the site, site environment

Updated Coordinates (if available): from a hand-held GPS or a GPS phone app

Where taken on site: where on the site the coordinates were gathered (if available)

Artifacts Visible on the Surface: check if artifacts are present

Concerns and Site Changes (check all that apply)

Erosion/Site washing away: including erosion from water or wind

Flooding/Submergence: water covering a part or all of site

Wind Impacts/Tree blow-down: high winds have altered the site

Wildfire: fire has affected the site

Drought: drought conditions are noticeable at the site

Development/Construction: human interventions, including adding armour stone or tree cutting

Vandalism/Looting: metal detection or digging activity, graffiti, etc.

Concerns and Site Changes Terms:

Some Impact to Site: noticeable changes to the site

Significant Impact (major changes to the appearance or character of the site): major changes to the site

You do not need to check either box if the concern or site change is not happening at your site

Other Concerns or Additional Information: other information or more detail about site threats.

Reporter Name: name of the person filling out the form

<u>Affiliation:</u> reporter's community, heritage, or other group (if applicable)
